Athletic Waiver and Release of Liability

I assume all the foregoing risks and accept personal responsibility for my personal damages following my injury, permanent disability or death. Intending to be legally bound, I do hereby release, waive, discharge and covenant not to sue Christie Mountain, its owners, landlords or officers, The Christie Mountain Ski patrol, race organizers, volunteers of the organization, other participants, sponsoring agencies, all of which are hereinafter referred to as "releasees", from any and all liability to me, my heirs for any claims, demands, losses or damages on account of injury, including death or damages to property, caused or alleged to be caused in whole or in part by negligence of any releasee or otherwise in connection with association or participation in this event. In the event that I sustain injury or illness while participating, I hereby authorize any emergency first aid, medication, medical treatment or surgery deemed necessary by licensed medical personnel. I also give my permission for attending medical personnel to execute on my behalf my permission forms or other necessary medical documents and to act in my behalf if I am not immediately available to do so.
